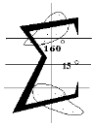

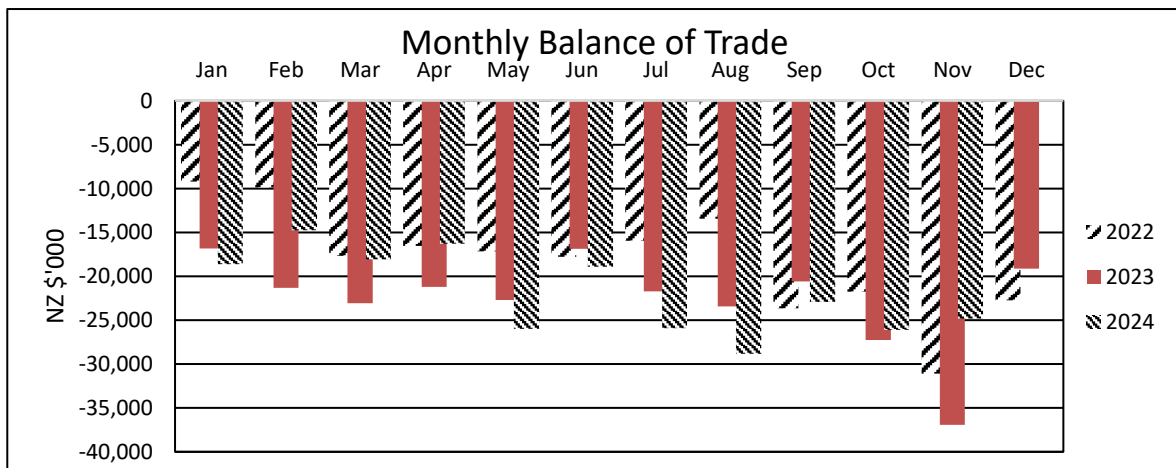
November 2024

Balance of Trade – The balance of trade deficit for the month of November 2024 was \$24.8 million. In comparison, this has improved by \$1.3 million over the previous month of October 2024 and by \$12.1 million over this time last year (November) 2023.

Exports – Total exports for the month of November 2024 stood at \$2.8 million. 97.5 per cent of this were fish exports. The bulk of our exports were destined for New Zealand market with a share of 91.6 per cent.

Imports – Total imports for the month of November 2024 was \$27.6 million predominantly of Food items (\$7.4 million), followed by Machines transport and equipment's (\$6.3 million), Miscellaneous manufactured goods (\$3.5 million), Basic manufactured goods (\$3.1 million), Mineral fuels (\$2.6 million), and Chemicals and, Beverages and Tobacco both at \$1.8 million respectively. More than 80 per cent of our imports are from New Zealand.

Taxes Generated from Imports – Total revenue generated from imports for the month of November 2024 was \$4.8 million of which \$4.4 million was from Value Added Tax (VAT) and, \$0.4 million were from import duties.
