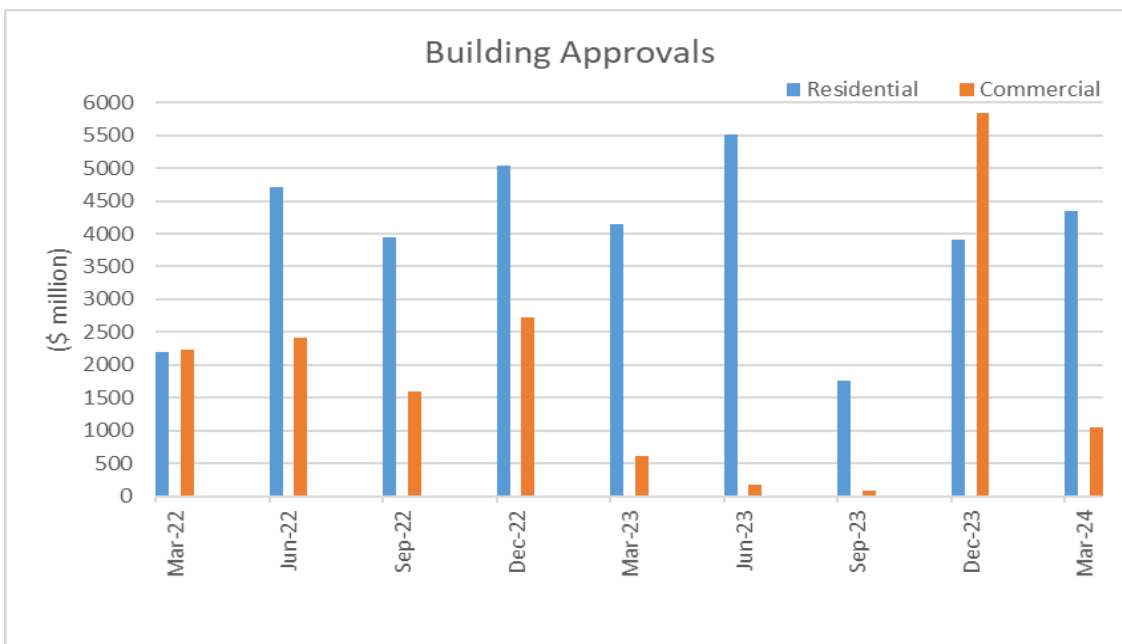

**BUILDING CONSTRUCTION STATISTICS**  
**March Quarter 2024**

**Building Approvals** – The total Building permits issued for March quarter 2024 stood at 27. This is the same number of permits when compared to December quarter 2023.

In this March quarter 2024, the total value of building approvals amounted to \$5.4 million. Residential buildings contributes the majority of this value at 80.6 per cent, while accommodation buildings contribute the remaining 19.4 per cent.
