1	Consumer Price Index (CPI) – is a quarterly measure of the overall cost of goods and services bought by a typical household (consumer). It is a measure of the general price level in the country. 2	Tourism and Migration Statistics is released every month on the number of travelers crossing our border, both visitors and residents. 3	Banking Survey – provides a quarterly consolidated statement of the accounts of the monetary authorities, deposit money banks, and other bank-like institutions of the Cook Islands, excluding the accounts of non-bank financial institutions. 4	Tax Statistics – is a quarterly release of Value Added Tax (VAT) data. This series is published at the end of the third month after the reference period. 5	Vital Statistics and Population Estimate – is a quarterly release of vital events (births, deaths and marriages). The source of this information is the vital registrations filed with the Ministry of Justice. Please note that Vital events occurring overseas are not included. 6	Miscellaneous Group – is a quarterly compilation of statistics from various government and non-government agencies. It covers a range of statistics such as climate, building approvals, aircraft movement, air cargo, and motor vehicle registration. 7	International Trade - presents monthly details on the value of merchandise imports into the country, and exports out of the country. Merchandise imports are classified by the Cook Islands Pacific Harmonized Customs Tariff Schedule (HS2017) which corresponds to the Standard International Trade Classification (SITC) Rev4. 8	Balance of Payments – is an annual summary of the economic and financial transactions of the residents of the Cook Islands with residents of other countries. 10	National Accounts - covers annual estimation of the country's Gross Domestic Product (GDP) by sector and industries. It includes the growth rate of each economic sector, their contribution to GDP and seasonal adjustments.
